

### **GENERAL EXPERIENCE**

Bente has worked with international development for 30+ years. She holds a Master Degree (*Magisterkonferens*) in Social Anthropology from Copenhagen University and diplomas in management and leadership.

Bente has worked with **monitoring, evaluation and learning** throughout her career – in development programs, as NGO manager and as a consultant. She has a solid command of participatory evaluation techniques and tools and a thorough knowledge of different **donor evaluation guidelines**, including Sida, Danida, NORAD, Finnida, DFID and EU.

Bente has extensive experience with human rights/HRBA, gender and youth programs, and social and financial inclusion, gained e.g. through baseline study for UNICEF/Danida in Myanmar to design Social Protection Development Plan for Chin State (2014), several assignments for Danish Association of the Blind (2013, 2014, 2016), appraisal of BØRNEfonden's West Africa Youth Program (2016); advocacy training of the Malian youth organization ASDAP (2017) with focus on youth, SRHR, GBV and FGM; design of baseline data collection and monitoring system for the Youth Empowerment in West Africa program (2017-18); development of Youth Engagement and Mainstreaming Tools for Danida (2018-19) with focus on transformative youth development; and evaluation of Sida's application of HRBA in development cooperation 2010-2019 (2019-2020) aimed at identifying lessons learned and innovative approaches to HRBA.

She has extensive experience with **women and youth financial inclusion in market system development** programs (FSD Zambia, 2019, 2020) including assessment of innovative fintech solutions, engagement of digital financial solutions and mobile money for women's and people with disabilities' economic empowerment and inclusion; and a Gender Peer Review of FSD Africa's programs in eight African countries with focus on extracting lessons learned on innovative and norm breaking ways of working with women's financial inclusion and economic empowerment through e.g. new technology (FSD Africa Network 2020). She is currently undertaking a final evaluation of Sida's support to Agency of Gender Equality in Kosovo 2015-2020 (2020-21) and a review of UNWomen's and UNFPA's Innovation facilities (2020-21).
