Personal Data

a) Personal data that is collected

b) Purpose of use of the Personal data

Submitting your CV to Bente Consulting via personal email contact leads to the inclusion in our CV-register which will contain the information submitted by you. Is your profile found to be qualified and suitable as part of a consultant team, your data will be shared with external clients only on proposals in which you have agreed to participate.

Financial details are not shared, but are only used by Bente Consulting.

Bente Consulting is not responsible for the privacy policies or practices of clients and partners to which we share Consultants' CVs as part of proposals or contracting.

The data about Individuals working in organizations can be made available to the organizations and Bente Consulting can contact them for cooperation opportunities, with the sole purpose of ensuring efficient contract management and communication.

Any financial data is only stored and processed for the purpose of

- performing financial transactions between Bente Consulting and the client/consultants, or
- respecting Danish legal obligations.
